

ORDINANCE 2021-10

**AN ORDINANCE OF THE CITY OF MT. WASHINGTON, BULLITT COUNTY, KENTUCKY
ADOPTING HOURS OF OPERATION AND FEES FOR THE CITY OF MT. WASHINGTON
SWIMMING POOL.**

WHEREAS, the City of Mt. Washington recently purchased the pool property located adjacent to Mt. Washington Middle School from the Bullitt County Board of Education,

WHEREAS the City of Mt. Washington desires to establish hours of operation and fees for the pool,

WHEREAS, the City Council has determined it is in the best of the City of Mt. Washington and the public to establish hours of operation and fees for the pool,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOUNT WASHINGTON, KENTUCKY HEREBY ADOPTS THE HOURS AND FEES AS FOLLOWS:

SECTION I

HOURS OF OPERATION

The Mt. Washington Swimming Pool will open to the public daily on Tuesday through Sunday from 10:00AM to 6:00 PM

The swimming pool season begins Memorial Day weekend and will be accessible to the public through Labor Day weekend each year

GENERAL ADMISSION

The fee for daily admission is \$5.00

Exemptions: There is free admission to children under the age of two (2) and adults sixty-three (63) and older.

POOL RENTAL

Pool Rental fees are \$225.00 for 2 hours including 2 lifeguards, \$75.00 for each additional hour

POOL RENTAL HOURS

6:30 PM -8:30 PM, unless additional time is requested on Fridays, Saturdays, and Sundays

For the safety of everyone utilizing the facility, all posted swimming pool rules and regulations must be followed at all times

MANAGEMENT RESERVES THE RIGHT TO REFUSE ADMITTANCE TO OR EJECT FROM THE POOL PREMISES ANY PERSON FAILING TO COMPLY WITH ANY POSTED HEALTH, SAFETY REGULATIONS.

SECTION II: This Ordinance shall be published according to law.

SECTION III: The effective date of this Ordinance shall be the date on which the Ordinance is published according to law.

SECTION IV: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

SECTION V: The City Clerk is hereby authorized to publish this ordinance in accordance with the Kentucky Revised Statutes.

Given a second reading at a regular meeting of the City Council of the City of Mt Washington, Bullitt County, Kentucky, on this 14th day of June 2021.
